Product Name: Fabric

Brief Description: Commercial furnishing fabric and the like, made variously from wool, nylon, polyester and recycled polyester. This covers all fabrics sold by SLF

2. ORGANISATION and PRODUCT DESCRIPTION

SLF ORGANISATION boundaries cover all corporate group members and all facilities under operational control of corporate members. The main emission sources are electricity, gas and fuel.

SLF PRODUCT boundaries cover from and include raw materials through all production processes to finished fabric then delivery to the customer and the disposal of the fabric at end of life to a recycling plant or to landfill.

The life cycle stages and emission sources are: – raw materials (sheep and oil), - Processing (electricity, gas, oil and coal), – Transport (fuel), – packaging (all from recycled materials, but not NCOS certified), – waste and disposal (at landfill or to recycling).

7. OTHER INFORMATION

In the year prior to becoming Greenhouse Friendly certified, the company followed the principles of determining its carbon footprint, and then reducing this as much as possible before seeking Greenhouse Friendly Carbon Neutral certification. The first determination of the carbon footprint was 5,752 tonnes CO₂-e for 2005/6 and by the time the company was Greenhouse Friendly certified in May 2007 this figure had been reduced to 3,447 tonnes CO₂-e, a reduction of 40.1%. Most of this reduction was from changes made within the product supply chain. Since that time the company has made further reductions to its carbon footprint to 2,813 tonnes CO₂-e in 2009/10 making a total reduction since 2005/6 of 51.1%.
