

1. Carbon neutral information

1A. <u>Introduction</u>

Molecular Approaches to Malaria Conference 2020 (MAM2020) is a 5 day event held in Lorne, Victoria where over 400 delegates are expected to attend. MAM2020 will feature leading experts in the field of malaria biology who will discuss strategies to reduce the global burden of malaria.

With a focus on how to minimise our impact on the environmental and understanding the links between the natural environment and health it was deemed appropriate to make our event carbon neutral.

2. Emissions reduction measures

Flights have been identified as a primary emission source due to international and national travel. Unfortunately, as an avoidable emission for the event, offsetting, carbon neutrality was chosen to lighten our impact.
