### 2. CERTIFICATION INFORMATION

### **Description of service certification**

This service certification is for the personal transaction deposit products (excluding Credit Card, Lending, Paylater and Term Deposit products) of Suncorp Bank (Norfina Limited) ABN 66 010 831 722.

- Functional unit: Average number of personal transaction deposit accounts active during the reporting period. The unit is number of accounts.
- Offered as: Full coverage service
- Life cycle: Cradle-to-grave

This Public Disclosure Statement includes information for the FY2023-2024 (30 June 2024) reporting period. Scope 3 emissions impacts from investments, insurance operations and 'financed' emissions are not included within the inventory boundary as the carbon neutral assessment is limited to Suncorp Bank's personal transaction deposit account service certification.

### **Description of business**

All personal transaction deposit products (excluding Credit Card, Lending, Paylater and Term Deposit products) within Suncorp Bank's transaction portfolio ('Transaction Accounts') are certified. Depending on the product type, personal transaction accounts can be accessed via a range of options which include digital channels (Suncorp Bank App and Internet Banking), branches and contact centre. All options to access the transaction accounts and features including physical debit cards, paper statements and ATMs are included in the certification.

The organisation operations of Suncorp Bank (Norfina Limited) are also certified Carbon Neutral under the Climate Active program. The personal transaction deposit products service of Suncorp Bank's carbon neutral boundary includes the direct operational footprint within its operational control and other emissions assessed as relevant which can be influenced by Suncorp Bank including:

- retail branches (excluding agencies)
- commercial offices
- customer contact centres
- business banking centres
- stand-alone and in-store ATMs
- data centres
- Suncorp Bank branded tool of trade vehicle fleet
- travel emissions including business travel<sup>1</sup> and employee commute and
- working from home emissions.

Suncorp Bank does not operate any branches in Northern Territory where services are provided through Australia Post "Bank @ Post" services and the RediATM and ATMx networks. These activities are included under the spend based method.

<sup>1</sup> Includes business-related flights, business-related travel in personal vehicles, business-related taxi travel and business-related rental vehicle travel.

### 3.EMISSIONS BOUNDARY

### Inside the emissions boundary

All emission sources listed in the emissions boundary are part of the carbon neutral claim.

**Quantified** emissions have been assessed as 'attributable processes' of a product or service. These attributable processes are services, materials and energy flows that become the product or service, make the product or service and carry the product or service through its life cycle. These attributable emissions have been quantified in the carbon inventory.

- Outsourcing The emissions are from outsourced activities that were previously undertaken by the
  responsible entity or from outsourced activities that are typically undertaken within the boundary for
  comparable products or services.
